WARRANTY DEED WITH VENDOR'S LIEN

) KNOW ALL MEN BY THESE PRESENTS:

That LONGHORN INVESTORS, LTD., a Texas Limited Partnership, acting herein by and through its duly authorized officers, hereinafter called GRANTOR, in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other consideration cash in hand paid by:

a Texas corporation, hereinafter called GRANTEE, and the further consideration of the execution and delivery by GRANTEE of a note payable to the order of GRANTOR in the principal amount of SIX HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$650,000.00), bearing interest and being payable as therein set out; said sum being secured by a Vendor's Lien hereinafter retained and by Deed of Trust of even date herewith covering PARCEL 1 and PARCEL 2 ONLY; has GRANTED, SOLD AND CONVEYED, and by these presents does GRANT, SELL AND CONVEY unto the said GRANTEE all that certain tract or parcel of land situated in Aransas County, Texas, described as follows:

UPON GRANTEE'S heirs, administrators, successors and assigns.

Taxes for the current year having been prorated, the payment thereof is hereby assumed by GRANTEE.

TO HAVE AND TO HOLD the above described premises, together with all and singular, the rights and appurtenances thereto in anywise belonging unto the said GRANTEE, GRANTEE'S heirs, administrators, successors and assigns forever; GRANTEE is hereby bound TO WARRANT AND FOREVER DEFEND, all and singular, the said premises unto the said GRANTEE, GRANTEE'S heirs, administrators, successors and assigns, against every person whatsoever lawfully claiming or to claim the same or any part thereof.

BUT, IT IS EXPRESSLY AGREED AND STIPULATED that a Vendor's Lien, including the superior title, is retained against the above described PARCEL 1 and PARCEL 2 ONLY, until the above described note and all accrued interest thereon, and all renewals and extensions thereof, together with all interest thereon, has been fully paid according to its tenor, effect and reading, and together with all additional sums that may become due and payable by the terms of said note, when this deed shall become absolute.

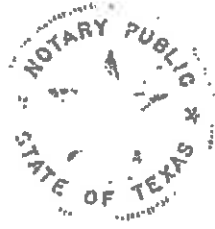
